5.2 MARYANNE LOMAX – ELMWOOD SCHOOL WAR MEMORIAL

Maryanne Lomax, Community Development Adviser, was in attendance to provide information requested previously by the Board in response to the Merivale Precinct Society's previous request for discretionary funding to repair the War Memorial situated on Elmwood Primary School's grounds. The ownership of the land and the memorial were clarified as belonging to the school and that any on-going maintenance would be the responsibility of the school.

The Board were also advised that fund raising was well under way and the projected cost of the repair was considerably less than originally envisaged.

13. APPLICATIONS TO THE BOARD'S 2011/12 DISCRETIONARY RESPONSE FUND

The Board's consideration was sought for funding from its 2011/12 Discretionary Response Fund from Riccarton Leagues Club, Anglican Parish of Burnside-Harewood, Merivale Precinct Society and Burnside Elim Church Trust.

STAFF RECOMMENDATION

It is recommended that the Fendalton/Waimairi Community Board:

BOARD CONSIDERATION

After some discussion the Board was of the opinion that before allocating any significant funds from its Discretionary Response fund, a workshop be arranged to discuss strategies for the optimum use of the fund's increased balance for 2011/12.

The Board resolved:

- (a) To allocate \$3,000 to the Anglican Parish of Burnside-Harewood towards Youth Worker wages from its 2011/12 Discretionary Response Fund.
- (b) To allocate \$1,500 to the Merivale Precinct Society towards the costs of hosting the annual Christmas Carol and Family barbeque event from its 2011/12 Discretionary Response Fund.
- (c) To decline the application from the Riccarton Leagues Club towards a shower block upgrade due to the significant funds already received from the Riccarton/Wigram Community Board and request that staff encourage the Club to investigate other funding sources. However, in the event that after other sources have been exhausted and a shortfall still exists to re-apply for funding from the Board.
- (d) That the application from the Burnside Elim Church Trust lie on the table until after a workshop for strategic planning on funding allocations has taken place.
