# 4.1 CHARLESTON NEIGHBOURHOOD ASSOCIATION INCORPORATED

# 5.2 HAGLEY/FERRYMEAD (WPASC) TALENTED SWIMMER SCHOLARSHIPS

Diana Saxton, Community Recreation Adviser Hagley/Ferrymead advised the Board that three Hagley/Ferrymead (WPASC) Talented Swimmer Scholarships had been awarded for 2011/12 by the Assessment Committee, and introduced the recipients Brittany Tucker, Charles Porter and Sean Hartgers.

Jenny Johnston, Administrator for Swimming Canterbury West Coast gave a brief overview of the measures put in place to ensure continuity of training and support following the disruption of facilities post earthquake.

The recipients, Brittany, Charles and Sean gave a brief overview of their achievements, were presented with certificates by Board Chairperson and received congratulations from the Board.

#### 5.2 SUMNER ROAD

Paul Burden, Road Corridor Operations Manager, briefed the Board on Sumner Road which is closed due to rockfall as a result of earthquakes. The Board were advised of the options being considered for the future of the road and the work that would be required to allow the road to reopen.
