**4.1 PARKING RESTRICTIONS IN COLLEGE AVENUE**

Correspondence from Mr Paul Cary of College Avenue regarding a request for P120 parking restrictions was tabled.

Staff gave background information regarding this matter including the original correspondence and petition from residents. Staff advised that due to the change of priorities arising from the earthquakes of September 2010 and February 2011 this request had been noted but no in depth work had been possible. Staff also advised the Board that the request would have wider implications for traffic and parking management in the area and would require extensive work.

Board members discussed the matter at length and explored a number of aspects with staff including previous parking related reviews in the locality. As a consequence, the Board **decided:**

- (a) to respond to Mr Cary regarding his request for P120 parking restrictions in College Avenue and to also place the response in context of the post earthquake situation and priorities across the city; and further

- (b) to request staff to consider a more comprehensive parking review for this road and surrounding areas to include local schools and other organisations and that feedback on the progress of this review be reported back to the Board within 12 months.
