**7. APPLICATION TO RICCARTON/WIGRAM 2011/12 DISCRETIONARY RESPONSE FUND – COMMUNITY DEVELOPMENT NETWORK TRUST - WYCOLA TEEN HANG OUT AND ILLAM SCHOOL INTERNATIONAL TOURNAMENT OF MINDS COMPETITION**

The Board considered a report from Ilam School seeking approval for:

- (a) funding from the Riccarton/Wigram 2011/12 Discretionary Response Fund towards travel costs for seven students attending the International Tournament of Minds who live in the Riccarton/Wigram ward; and
- (b) from the Community Development Network seeking approval for funding from the Riccarton/Wigram 2011/12 Discretionary Response Fund towards the purchase of a security system and as a contribution towards equipment for the Wycla Teen Hang Out.

The Board **resolved** to:

- (a) grant \$1,200 from the Riccarton/Wigram 2011/12 Discretionary Response Fund towards travel costs for seven students attending the International Tournament of Minds who live in the Riccarton/Wigram ward; and
- (b) grant \$2,000 from the Riccarton/Wigram 2011/12 Discretionary Response Fund towards the purchase of a security system and as a contribution towards equipment for the Wycla Teen Hang Out.
