## **7. USE OF BURWOOD LANDFILL TO SUPPORT EARTHQUAKE RECOVERY OPERATIONS**

Mr Christison presented his report and answered questions from members, advising that Burwood Landfill could be reopened in the event of another extreme emergency or by using the RMA process, but that the Council is committed to the Kate Valley Landfill site.

The Committee **received** the information.

## **8. FUTURE MEETING DATES**

The Committee was advised of potential meeting dates for the year ahead which also fitted with the reporting obligations of Transwaste Canterbury Ltd. It was noted that these meeting dates fell on a Friday.

## **9. KATE VALLEY LANDFILL – OPERATION AND EFFECTS OF EARTHQUAKE**

Martin Pinkham briefed the Committee on the effects of the earthquake on Kate Valley Landfill, explaining how the increased tonnages of waste were dealt with. His briefing was accompanied by a PowerPoint presentation.
