**SHIRLEY/PAPANUI COMMUNITY BOARD
17 NOVEMBER 2010**

**Report of a meeting of the Shirley/Papanui Community Board,
held on Wednesday 17 November 2010 at 4.06pm
in the Boardroom, Papanui Service Centre, corner Langdons Road and Restell Street, Papanui.**

PRESENT: Chris Mene (Chairperson), Ngaire Button, Kathy Condon, Pauline Cotter, Chris English and Aaron Keown.

APOLOGIES: An apology for absence was received and accepted from Anna Button.
Apologies for early departure were received from Aaron Keown who retired from the meeting at 6.37pm and was absent for clauses 6, 7, 8, 9, 17 and 18 and Ngaire Button who retired from the meeting at 7.20pm and was absent for clauses 6, 7, 8, 9 and 18.

PART B - REPORTS FOR INFORMATION

1. JOHNS ROAD – PROPOSED P120 PARKING RESTRICTION

The Board considered a report seeking a recommendation to the Council to approve that a P120 Parking Restriction be installed on the south side of Johns Road for a distance of 30 metres, just east of the intersection with Swift Street.

After receiving advice from staff that a delay would not cause any significant implications, the Board **decided** to lay the matter on the table and that staff be requested to investigate extending the proposed parking restriction on the south side of Johns Road to its intersection with Swift Street and present this to the Board as soon as possible.

2.1 ROBIN FRISBY – ABBERLEY PARK TREES

Robin Frisby advised the Board on issues of shading and root intrusion from Abberley Park trees and the effect on his property.

- (a) The proposal by Mr Frisby to have a branch removed from the Chinese Wingnut and removal of the two Purple-leaf Cherry Plum trees from Abberley Park adjacent to his property at 2/13 Abberley Crescent.
- (b) The effects of shade, limbs and root intrusion into the property at 2/13 Abberley Crescent from the Abberley Park trees.

In response to the Board’s request of 14 April 2010 staff provided a memorandum giving information on the feasibility of installing no stopping signs in the service lane behind the Acheson Avenue shops.

7.3 ACHESON AVENUE SERVICE LANE – PARKING ENFORCEMENT

In response to a request from a resident in April 2010 seeking assistance with parking issues in Acheson Avenue Service Lane staff provided a memorandum giving information on the feasibility of increasing parking enforcement in this lane on Saturday mornings when illegal parking was prevalent.

12. GOODALL PLACE – PROPOSED NO STOPPING RESTRICTION

The Board considered a report seeking approval that the stopping of vehicles be prohibited at any time on the north and south side of Goodall Place and on the western side of Lowry Avenue at its intersection with Goodall Place.

The Board **resolved** to:

Approve the following on Goodall Place:

- (a) That the stopping of vehicles be prohibited at any time on the north side of Goodall Place commencing at its intersection with Lowry Avenue and extending in a westerly direction for a distance of 38 metres.
- (b) That the stopping of vehicles be prohibited at any time on the south side of Goodall Place commencing at its intersection with Lowry Avenue and extending in a westerly direction for a distance of 10 metres.

Approve the following on Lowry Avenue:

- (c) That the stopping of vehicles be prohibited at any time on the west side of Lowry Avenue commencing at its intersection with Goodall Place and extending in a northerly direction for a distance of 11 metres.

- (d) That the stopping of vehicles be prohibited at any time on the west side of Lowry Avenue commencing at its intersection with Goodall Place and extending in a southerly direction for a distance of 12 metres.

13. MASSEY CRESCENT AT TRAFALGAR STREET – PROPOSED NO STOPPING RESTRICTION

The Board considered a report seeking approval to extend the existing 'no stopping' restriction in a south-west direction on both sides of Massey Crescent at Trafalgar Street intersection.

The Board **resolved** to:

Revoke the following parking restrictions:

- (a) That any existing parking restrictions at any time on the west side of Massey Crescent commencing at its intersection with Trafalgar Street and extending in a south-west direction for a distance of 10 metres, be revoked.
- (b) That any existing parking restrictions at any time on the east side of Massey Crescent commencing at its intersection with Trafalgar Street and extending in a south-west direction for a distance of six metres, be revoked.

Approve the following:

- (c) That the stopping of vehicles be prohibited at any time on the west side of Massey Crescent commencing at its intersection with Trafalgar Street and extending in a south-west direction for a distance of 30 metres.
- (d) That the stopping of vehicles be prohibited at any time on the east side of Massey Crescent commencing at its intersection with Trafalgar Street and extending in a south-west direction for a distance of 13 metres.
