**PART B – REPORTS FOR INFORMATION**

**1. WELCOME**

Lisa Goodman, Democracy Services Manager, representing the Chief Executive, welcomed all present and outlined the procedures for this meeting.

**2. GENERAL EXPLANATION**

It was felt that it was preferable to travel during the day, rather than in the evening or at night. The Board asked Councillor Reid to convey that message to the Council.
