1. APOLOGIES

Apologies for absence were received and accepted from Councillors Button and Reid. An apology for early departure was accepted for Councillor Williams who left the meeting at 11.06am.

Councillor Williams' apology for the Council meeting on 10 February 2011 was accepted.

2. DEPUTATIONS BY APPOINTMENT

Louette McInnes representing Neighbourhood Support groups in Ilam addressed the Council regarding item 6, the Temporary Alcohol Ban for the University of Canterbury Orientation Period in support of the temporary ban.

Kohan McNabb, President Students Association also addressed the Council about item 6 and while supporting measures to reduce any illegal or anti-social behaviour, did not agree that the temporary ban is an effective way to do this.

6. TEMPORARY ALCOHOL BAN FOR UNIVERSITY OF CANTERBURY ORIENTATION PERIOD

Item 6 was taken at this stage of the meeting.

Councillor Williams left the meeting at 11.06am.

Councillor Wells, moved seconded by Councillor Broughton, that the Council:

- (a) *That having considered the matters in clause 5(2) of the Christchurch City Council Alcohol Restrictions in Public Places Bylaw 2009, the Council declares, for the area in Ilam (being the area shown in the attached map), a Temporary Alcohol Ban covering 24 hours per day from 12am on 17 February 2011 to 12pm on 27 February 2011.*
- (b) *That clause 8(1) of the Christchurch City Council Alcohol Restrictions in Public Places Bylaw 2009 applies to the Temporary Alcohol Ban described above.*
- (c) *That Public Notice be given in The Press on 3 February 2011 and advertising through the University of Canterbury Students Association be undertaken and signs be provided in the public places covered by the Temporary Alcohol Ban.*
- (d) *That an unbudgeted sum of up to \$20,000 be approved for the purposes of providing signage and conducting advertising to make students and the public aware of the temporary alcohol ban in the area.*
- (e) *That Council staff work closely with UCSA and the University of Canterbury Administration to ensure a good communication plan to ensure students are informed.*

Clause (d) when put to the meeting was declared **carried** on electronic vote No. 2 by 9 votes to 2, the voting being as follows:

Against (2): Councillors Keown and Johanson.

Clause (e) when put to the meeting was declared **carried** unanimously on electronic vote No. 3, the voting being as follows:

For (11): Councillors Broughton, Buck, Carter, Chen, Corbett, Gough, Johanson, Keown, Livingstone, Wells and the Mayor.
