1. DEPUTATIONS BY APPOINTMENT

1.1 MR TREVOR SWAINSON, PROPERTY MANAGER OF FERRY MEAD HOUSE

Mr Trevor Swainson, Property Manager of Ferry Mead House, addressed the Recess Committee regarding the request of The Tramway Historical Society Inc. to operate the trams on the northern part of the tram lines in Ferrymead Reserve. Mr Swainson expressed concerns regarding potential damage to Ferry Mead House and the speed at which the trams travel.

Mr Graeme Belworthy, the President and Mr Dave Hinman, Secretary of The Tramway Historical Society Inc., addressed the Recess Committee regarding the request of the Society to operate the trams on the northern part of the tram lines in Ferrymead Reserve, and presented a written submission in support of the application.

PART C - REPORT ON DELEGATED DECISIONS TAKEN BY THE RECESS COMMITTEE

2. REQUEST OF THE TRAMWAY HISTORICAL SOCIETY INC.

The Committee considered an application from The Tramway Historical Society Inc., seeking approval for the operation of trams on the northern part of the tram lines in Ferrymead Reserve between the hours of 2pm and 4pm on Sunday 6 February 2011 to mark the 50th anniversary of the founding of the Society. Three deputations were heard on this matter, clauses 1.1 to 1.3 refer.

It was **resolved** unanimously on the motion of Bob Todd, seconded by David Cox, that Hagley/Ferrymead Community Board Recess Committee grant permission to The Tramway Historical Society Inc., to operate each tram on the northern part of the tram lines in Ferrymead Reserve between the hours of 2pm and 4pm on Sunday 6 February 2011, conditional that the speed be limited to five kilometres per hour and limited to four trips.

(Note: A trip is defined as there and back to the end of the line for each tram.)

The Chairperson thanked Recess Committee members and staff for their attendance and contributions, and declared the meeting closed at 10.27am.
