# Lyttelton Reserves Walking Tracks

Members were informed that almost all Port Hills reserve tracks are closed due to earthquake damage and rockfall threat. Concern has been expressed by staff that people are still using the tracks despite warnings and erected closure signs. Damaged fences are also allowing stock into the reserves. Reserves are being checked weekly and it is likely to take months before they reopen after winter. Priority will be given to opening the Bridle Path.
