**1.2 CANTERBURY RUGBY FOOTBALL UNION AND SPORT CANTERBURY – STEVE LANCASTER, HAMISH RIACH AND GEOFF BARRY**

Steve Lancaster and Hamish Riach (CEO) of Canterbury Rugby Football Union and Geoff Barrie (CEO of Sport Canterbury) discussed the possible future integrated look and feel of Rugby and Malvern Parks with the Board.

The Board was appreciative of the early approach on the proposals for Rugby and Malvern Parks and **agreed** that a site visit be arranged to inspect the facilities. The Board further **agreed** on their support in principle for the Canterbury Rugby Football Union's initial proposals for Rugby and Malvern Parks.

Democracy Services Unit	<p><b>Communication with the Community</b></p> <p>The Board has previously committed funding for communicating with their community through articles/columns in local newspapers and wishes to continue with this practice and include also communicating through other media.</p>	\$5,000
Community Support Unit	<p><b>Garden Pride Awards</b></p> <p>This is a partnership between the Christchurch City Council and the Christchurch Beautifying Association (CBA) to acknowledge the work of residential gardeners who, by their efforts, have contributed to Christchurch's garden city image by beautifying their streets and garden frontages.</p> <p>Judging is undertaken by the Christchurch Beautifying Association in January with a ceremony held in March/April 2012.</p> <p>Expenditure will be for certificates, catering, venue hire, photography and other associated administration costs.</p>	\$3,200
Community Support Unit	<p><b>Neighbourhood Week</b></p> <p>Neighbourhood Week is a week dedicated to getting to know the people who live close to you. It's about bringing people together, whether a few households or a larger neighbourhood gathering.</p> <p>Neighbourhood Week 2010 will be held over the week of 29 October – 6 November . Each year we receive over 60 applications with over 1,600 people participating.</p> <p>Those who participate in Neighbourhood Week feel a sense of community with their immediate neighbours, and they feel safer in their homes and with their children playing together in the street.</p> <p>Expenditure will be for subsidies towards community neighbourhood events.</p>	\$3,500
Community Support Unit	<p><b>Community Service Awards</b></p> <p>Community Service Awards are awarded to individuals and/or groups in recognition of significant voluntary service in the S/P ward. The Community Service Awards recognise voluntary efforts in the following areas: youth, aged, education, cultural, church, recreation, sport, community service fields.</p> <p>The awards are advertised city-wide and the Board receives all complying nominations and makes decisions on whom should be invited to receive an award.</p> <p>Applications will be called for in February/March with the ceremony held in May/June 2012.</p> <p>Expenditure will be for certificates catering, venue hire, photography, advertising, production of materials and other associated costs.</p>	\$4,500

Community Support Unit	<b>Heritage Awards</b> Not be held this year – reassess in 2012/13 funding round.	\$0
Chris Mene	<b>Graham Condon Recreation and Sport Centre Artwork</b> The artwork will recognise an individual's extraordinary contribution to the City and this ward, and provide a sense of connection for the residents of Papanui. Users' experience at the centre will be enhanced through a creative environment. Artworks have a 50-100 years presence and will create an intergenerational impact and legacy of inspiration to generations of citizens. The artwork will give due recognition and normalisation of people with disabilities. Most public artworks undertaken by the Community Boards have cost between \$20,000 and \$400,000. The board has already contributed \$14,000.	\$6,000
