**PART B - REPORTS FOR INFORMATION**

**1. DEPUTATIONS BY APPOINTMENT**

**1.1 MS ANITA BELL – CROSBIE PARK**

Ms Anita Bell, spokesperson for Group 1 of Avonhead Neighbourhood Support was in attendance and spoke to previously circulated documentation listing residents' concerns regarding anti-social behaviour in Crosbie Park. Issues discussed included evening and late night underage drinking, assault, vandalism, arson, graffiti, disorderly behaviour and intimidation.

The Board **decided** to initiate the following actions:

To request from Council staff:

- (a) That a CPTED audit be undertaken focusing on residents' concerns regarding antisocial behaviour and alcohol issues in Crosbie Park and the surrounding areas, including the potential for a liquor ban, security cameras, new signage and the locking of toilets over night; and which agencies can be involved to resolve these issues.
- (b) As a matter of priority the Mosquito Anti-Teen System to be installed by the Community Constable.
- (c) That a report on this matter be brought to the 14 June 2011 board meeting.

- That CERA meet with the Fendalton/Waimairi Community Board as quickly as possible for a first session and then plan for the remainder of the year; and
- That CERA meet individually with Christchurch City, Selwyn and Waimakariri Councils once a month.
