**SHIRLEY/PAPANUI COMMUNITY BOARD
18 MAY 2011**

**Report of a meeting of the Shirley/Papanui Community Board,
held on Wednesday 18 May 2011 at 8.03am
in Garden Room, St Albans Baptist Church, 64 McFaddens Road St Albans.**

PART B - REPORTS FOR INFORMATION

1. DEPUTATIONS BY APPOINTMENT

1.1 INSPECTOR DAVE LAWRY – NEW ZEALAND POLICE

Inspector Dave Lawry updated the Board on policing matters in the ward. There had been a reduction in crime in the ward, however there were social behavioural issues that would arise out of earthquake related stresses. Police had ongoing strategies in place to support and link the community, families and individuals.

With the increase of people in the ward, a change in business patterns and shared schooling, high visibility patrols were in place. This included more foot patrols in the Northlands Mall and main shopping areas and continued liaison with local businesses. The Earthquake Knowledge Profile, recently developed, would be shared with Council staff.

Inspector Lawry undertook to liaise with the Board on a crime reduction door-knocking campaign in spring.

The Board **decided** that Inspector Lawry be invited to brief the Board monthly.

1.2 RICHARD SHAW - NEW ZEALAND TRANSPORT AGENCY

Richard Shaw of New Zealand Transport Agency (NZTA) updated the Board on the five stages of the Western Corridor four lane roading project between Belfast and Yaldhurst.

The Board was informed that public consultation would be undertaken during June relating to the section of Johns Road between the Groynes and Sawyers Arms Road. Also that the consultation phase was nearing completion on the Western Belfast Bypass, with work expected to commence in 2015.

The planned works for the Western – Belfast bypass would have two minor encroachments on the Groynes dog park and these had been discussed with Council staff and park users. Construction in this section was expected in 2013/14 dependent on the consenting process.

The Groynes to Sawyers Arms section was in the design phase and would be out for consultation shortly. Improvements were planned for the Sawyers Arms and Harewood Roads roundabouts. Gardiners Road would be left out only at the Johns Road intersection.

1.3 HELEN ROSS – EDGEWARE VILLAGE GREEN INC.

Helen Ross and Ro Soryl advised the Board on the aims of Edgware Village Green Inc, which included providing a community garden that inspires and educates the community whilst being environmentally friendly and sustainable. Concept plans for the community gardens were displayed.

The group recently undertook several Edgware Road street clean-ups, and are working with Gapfiller in planning several community events in the near future. The group is also working with the Greening the Rubble group to temporarily 'green' the site of the demolished supermarket site in Edgware Road to enhance the area until a new supermarket is built.

The Chairperson invited representatives from Edgware Village Green Inc. to attend the Towards Recovery workshop being run by the Board on Thursday 19 May 2011.

The Board **decided** to seek clarification from staff on funding held for Edgware Village Green Inc., the release of which may have been dependent on the group's incorporation.

The Board Chair thanked all the deputations for their presentations and information.
