# PART B - REPORTS FOR INFORMATION

## 1. DEPUTATIONS BY APPOINTMENT

### 1.1 Jane Chart, Rose Stone, Penelope Brady and Graham Brady - Governors Bay

Ms Chart addressed the Board regarding roading improvements that had been made to Jetty Road in Governors Bay, over the last six months. Ms Chart was concerned that the newly widened and sealed road, which had replaced the narrow, unsealed one, would result in traffic moving faster on the road. Her main concern was that safety measures did not appear to have been incorporated into the upgrading project.

The deputees also raised concerns regarding boy racers who currently cause noise problems using Jetty Road in the early hours of weekend mornings. They suggested that judder bars, or some other road calming measures, could be a solution to slow traffic and reduce the problems caused by racing vehicles.

The Board **decided** to pass the residents concerns to staff for comment.

Board members also suggested that the residents contact the Lyttelton Police regarding the boy racer activity, as the newly commissioned Community Watch Car may be able to include the area in its patrols.

## Port Levy Residents' Association

Members were informed that the Port Levy Residents' Association had indicated its full support for the reconstruction and repair of the sheds on the Port Levy jetty, as had been requested by the Board at its April meeting.

# Gallipoli Jetty at Rapaki

Members were informed again that the state of disrepair of the Gallipoli jetty was causing concerns about its safety amongst the Rapaki community. The Board believed that the jetty had been gifted to the Rūnanga by the Banks Peninsula District Council in approximately 2004 or 2005.

The Board **decided** to ask the Rāpaki Rūnanga to provide a summary of what repairs/maintenance the jetty required and any further details on the extent of the project.

The Board further **decided** to ask staff to clarify the ownership of the jetty and whether it was a structure of historical importance, as it had reportedly been built circa 1915 as a memorial to local soldiers killed at Gallipoli.
