**2.1 EDWARD WRIGHT – ENVIRONMENT CANTERBURY**

**7. COMMUNITY BOARD ADVISER'S UPDATE**

The Board received updates from the Community Board Adviser on Board related activities. Specific mention was made of the following.

**7.1 Tree Maintenance – Oxley Avenue**

Staff tabled information responding to the Board's request of 2 June 2010 for staff to investigate if regular, rather than major one-off pruning of Christchurch street trees will resolve residents' concerns about maintaining street aesthetics.

**7.2 Styx River – Dredging and Kaputone Headwaters**

Staff tabled information responding to the Board's request of 29 June 2011 for the investigation of possible dredging of the lower Styx River to remediate earthquake damage and prevent planning, and also if the Kaputone Headwaters Reserve in Northlands wasted water and/or was a child safety hazard.

**7.3 Warrington Street Parking Issues**

Staff tabled information in response to the Board's request of 2 February 2011 to investigate reported parking problems outside 68 Warrington Street.

**7.4 Westminster Sports incorporated**

At the request of Westminster Sports Incorporated, information from staff was tabled on proposed temporary changing sheds at Westminster Park.

The Board **decided** to request staff to arrange a site visit to Westminster Park and also to reinstitute the Westminster Sports Monitoring Group meetings.

**8.1 Santa's Workshop**
