**1. DEPUTATIONS BY APPOINTMENT**

**1.1 HEATHCOTE VALLEY COMMUNITY ASSOCIATION**

**9. CONFIRMATION OF MEETING MINUTES - 14 SEPTEMBER 2011**

It was **resolved** on the motion of David Cox, seconded by Islay McLeod, that the minutes of the Board's ordinary meeting of 14 September 2011, both open and public excluded, be confirmed.

**10. APPLICATIONS TO THE HAGLEY/FERRYMEAD COMMUNITY BOARD 2011/12 DISCRETIONARY RESPONSE FUND - SEPTEMBER 2011**

The Board considered a report presenting three applications for funding from the Board's 2011/12 Discretionary Response Fund. Staff advised the Board that they intend to talk with the Asian Pacific Charity Trust in regard to the Eco-Travel Rickshaw project.

- (a) It was **resolved** on the motion of Bob Todd, seconded by Islay McLeod, that the Board approve a grant of \$1,200, from the 2011/12 Discretionary Response Fund, to the Redcliffs Public Library Inc. for 12 months storage of library books.

(Note: David Cox declared an interest and withdrew from the discussion and voting on resolution (a).)

- (b) It was **resolved** on the motion of Bob Todd, seconded by David Cox, that the Board approve a grant of \$1,716 from the 2011/12 Discretionary Response Fund, to St Chad's Anglican Church of Linwood toward the purchase and installation of a commercial dishwasher.

- (c) It was **resolved** on the motion of David Cox, seconded by Nathan Ryan, that the Board decline the application from the Asian Pacific Charity Trust for funding to support the Eco-Travel Rickshaw project.

**11. APPLICATION TO THE HAGLEY/FERRYMEAD COMMUNITY BOARD 2011/12 YOUTH DEVELOPMENT SCHEME – PHILIPPINE CULTURE AND SPORTS VOLLEYBALL TEAMS**

The Board considered a report seeking approval for an application for funding from its 2011/12 Youth Development Scheme from the Philippine Culture and Sports Society.

It was **resolved** on a motion of David Cox, seconded by Islay McLeod, that the Board support the application and allocate \$150 to each team member, totalling \$600, from the 2011/12 Youth Development Scheme as a contribution towards the trip to the Labour Weekend National Filipino Volleyball Tournament.

The Chairperson thanked Board members and staff for their attendance and contributions, and declared the meeting closed at 3.54pm.
