1. DEPUTATIONS BY APPOINTMENT

1.1 KATE BOULD AND FRANCES JAMES, GOVERNORS BAY COMMUNITY ASSOCIATION

Kate Bould and Frances James addressed the Board on behalf of the Governors Bay Community Association, regarding traffic safety issues with Dyers Pass Road and within the Governors Bay community. It was reported that as a result of the closure of Evans Pass and Sumner Road, and some restrictions on heavy trucks using the Lyttelton Tunnel, there has been an extraordinary increase in the numbers of very large, heavy vehicles on the roads around the harbour from Lyttelton to Governors Bay and over Dyers Pass.

The deputees on behalf of the Community Association requested that the Board endeavour to get safe preventative measures put in place now and continue to take steps towards getting Evans Pass reopened in the future. The Association offered to help in any way it could to assist in achieving these requests.

- **Canterbury Pilgrims Society**

It was reported that the annual Memorial Service would still take place this year and will be held on 16 December 2011 at the Norwich Quay site.

The Board **decided** to request that staff investigate and remedy minor damage done to the site as a result of the demolition work carried out when the neighbouring Post Office building was removed.

- **Governors Bay Traffic**

The Board **decided** to request that staff liaise with the Governors Bay Community Association and urgently consider some safety measures to mitigate the effects of increased heavy traffic and cyclists on Dyers Pass Road and the Lyttelton to Governors Bay Road.

The Board further **decided** to communicate with the Council to highlight the need for Evans Pass to be reinstated because of the effects its closure was causing on other roads. Board members cited reasons for reinstating the road, including its economic significance to the Lyttelton area, its importance to tourism, safety for other roads and its historical background.

- **Southport Funding**

It was reported that Southport (the port authority at Bluff) had a substantial sum of money to donate towards a community project as part of an earthquake donation to the Lyttelton community.

Members **decided** to request that staff urgently investigate the possibility of making improvements to the Lyttelton Skatepark including the relocation of the basketball half court, using funding from Southport.
