#### 4. BRIEFINGS

##### 4.1 NORTH WEST REVIEW AREA

Clare Piper (Associate Policy Planner), Lizzy Pearson (Senior Policy Analyst) and Ivan Thomson (District Planning Team Leader – North West Review Area) briefed the Board on the outcome of the recent North West Review Area consultation with the community.

The Chairperson thanked Clare Piper, Lizzy Pearson and Ivan Thomson for their briefing.

#### 5. CORRESPONDENCE

5.1 Letters were received from Joanna Gould expressing opposition to an aspect of the Acheson Avenue service lane no stopping restriction, which the Board had approved on 31 August 2011. Mrs Gould was opposed on safety grounds to the installation of parking bays at the western end of the Acheson Avenue service lane.

The Board **decided**:

- (a) To request that enforcement staff target compliance with the Acheson Avenue service lane no stopping restrictions, particularly during the times of weekend sports events.
- (b) To request staff to inform the Board in April and October 2012 of the efficacy of the no stopping restriction in the service lane in Acheson Avenue and the parking bays outside 21 Acheson Avenue. This information to include enforcement and any crash history data for the service lane.

#### 6. COMMUNITY BOARD ADVISER'S UPDATE

The Board received updates from the Community Board Adviser on Board related activities. Specific mention was made of the following.

##### 6.1 34 Courtenay Street

Staff tabled information responding to the Board's request of 14 September 2011 for information on the status of the property at 34 Courtenay Street, which on 14 April 2011 the Council declared surplus and approved for sale.

The Board noted that staff were waiting on insurance advice and a structural report for 34 Courtenay Street and **decided** that staff be requested to keep the Board informed when progress is made with the approved sale of the property.

##### 6.2 CERA Recovery Strategy

The Board received advice that public consultation on the Canterbury Earthquake Recovery Authority (CERA) Recovery Strategy will run until Sunday 30 October 2011.

The Board **decided** to hold a workshop at 3pm Wednesday 19 October 2011 for the purpose of preparing a submission on the CERA draft Recovery Strategy.

##### 6.3 Drinking Fountain – Scotts Engineering, Cranford Street

Staff tabled information in response to the Board's request to ascertain if any action could be taken to cap a drinking fountain located at Scotts Engineering, 506-510 Cranford Street. As the artesian well is on private property the Council has no authority in the matter.

**9. CONFIRMATION OF MEETING MINUTES – 14 SEPTEMBER 2011**

The Board **resolved** that the minutes of its ordinary meeting of 14 September 2011, be confirmed subject to several amendments:

Page 3, paragraph 1 of clause 9.1 – sentence to read:

Staff tabled an information memorandum in relation to the Board's request of 2 September 2011 for staff to address any safety and aesthetic issues at this intersection.

Page 3, paragraph 1 of clause 10.3 – sentence to read:

The Board members advised that at the Brooklands AGM a resident suggested that should the Brooklands properties be zoned red, that the Council consider a land swap of the village onto Selwyn Plantation land.

**10. SHERBORNE STREET REMOVAL OF P120 PARKING RESOLUTION**

The Board considered a report seeking approval to revoke the parking restriction outside 142 Sherborne Street.

The Board **resolved**:

- (a) To revoke the following on Sherborne Street:

That any existing parking restrictions be revoked on the eastern side of Sherborne Street commencing at its intersection with Edgware Road and extending in a southerly direction for a distance of 29 metres.

- (b) To approve the following on Sherborne Street:

That the stopping of vehicles be prohibited at any time on the east side of Sherborne Street commencing at its intersection with Edgware Road and extending in a southerly direction for a distance of 14.5 metres.
