# AKAROA/WAIREWA COMMUNITY BOARD 29 AUGUST 2011

Report of a meeting of the Akaroa/Wairewa Community Board held on Monday 29 August 2011 at 9.30am in the Akaroa Sports Complex, 28 Rue Jolie, Akaroa.

#### 1. DEPUTATIONS BY APPOINTMENT

# 1.1 DALE THOMAS - FRIENDS OF THE GAIETY

Dale Thomas addressed the Board regarding the Friends' concerns that due to the recent earthquakes the supper room of The Gaiety is closed to the public and therefore causing cancellations and preventing full use of the hall. She asked for the Board's support to progress the repairs to the supper room with urgency, and suggested that the repairs could take place in two stages. She also questioned whether the undamaged end portion of the supper room could be used in the interim, as this would give access to backstage.

Victoria Andrews also addressed the Board in support of Dale Thomas reiterating that The Gaiety was much used and the supper room needs to be repaired for the hall to be utilised to its full potential.

The Board decided to ask staff:

- (a) To urgently supply information on the situation relating to insurance for the earthquake damage to The Gaiety; whether the total repairs are covered by insurance, and the proposed timing of the repairs to enable the supper room facility to be operational before the cruise ship season commences in early October.
- (b) Whether any transitional arrangement can be made in conjunction with the community to provide an alternative until permanent repairs can be carried out.

#### 1.2 ROGER WOODS - FLETCHER EQR

Roger Woods (Banks Peninsula Hub Manager for Fletcher EQR) and Cheryl Hunt (Community Liaison Officer), updated the Board on earthquake recovery progress, and tabled a list of pertinent statistics.

#### 1.4 AKAROA AND BAYS LIONS CLUB

Eric Ryder spoke to the Board regarding projects the Club wishes to sponsor in Akaroa, to mark its 40<sup>th</sup> Anniversary, being:

- Installation of a shower at the Akaroa main beach.
- Illumination of the Akaroa Lighthouse (uplighting).
- Installation of an electric barbeque at the Akaroa Recreation Ground.
- Tidy and make safe the Akaroa Anglican Cemetery following the earthquakes.

The Board was informed that the tidying of the Akaroa Anglican Cemetery and also the Duvauchelle Cemetery had already been carried out.

Mr Ryder also informed the Board that the uplighting of the Lighthouse would need to be connected to the street lighting circuit and would be controlled under the same system. The beach shower would be connected to the main water supply and would therefore probably be subject to any water restrictions.

It was pointed out that a concrete pad already existed near the Akaroa Recreation Ground and Sports Complex for a barbeque, however this would need to be placed under a Council contract for cleaning and collecting of the money.

The Board **decided** to support these projects in principle and to ask staff to liaise with the Akaroa and Bays Lions Club in relation to the ongoing maintenance costs and implementation details of the proposed projects and to keep the Board informed on progress.

#### 8.2 STANLEY PARK RESERVE MANAGEMENT COMMITTEE

Rod Naish and Kit Grigg, on behalf of the Stanley Park Reserve Management Committee, updated the Board on some relevant issues concerning the park, these being:

- Slippery tracks.
- Replanting programme following gum tree removal has not occurred.
- Entrances to Stanley Park need repairing, Penlington Place in particular requires a lot of work.
- Weed spraying and management
- Felled trees need removing prior to summer to prevent a fire hazard.
- An illegal BMX track has been formed which is dangerous.
- Stiles need upgrading to comply with the National Standards for public walkways.
- Fire monitoring sign recently installed adjacent to the Akaroa fire station is too close to the entrance to Stanley Park.

The Committee also felt that the Draft Reserve Management Plan was too elaborate and costly when many small repairs required attention.

The Board **decided** to ask staff to meet with the Stanley Park Reserve Management Committee regarding the reported maintenance issues.

The Board **further decided** to ask staff to comment on the possibility of the Reserve Management Plan process being completed in the near future, as it had been so far advanced prior to the earthquakes occurring.
