**13. FENDALTON/WAIMAIRI COMMUNITY BOARD STRENGTHENING COMMUNITIES FUNDING 2012/13 – BOARD BIDS**

The Board was asked to consider its proposed bids being put forward to the 2012/13 Strengthening Communities Fund.

The Board discussed a number of additional ideas for projects including the development of a Community Map which would highlight community facilities, services and information in both a printed and electronic form.

Exact costs for this were to be confirmed prior to the Strengthening Communities fund meeting when final allocations would be made.

The Board reaffirmed its desire to increase the level of 'mainstream' information and communications through local newspapers.

The Board decided that the Community Map project should be added to the Board Bid list.

The Board noted that costs could not be confirmed at this stage.

The Board **resolved** to submit the following applications to 2012/13 Strengthening Communities Fund including the additional bid for the Community Map Information Project (estimated at a cost of \$5,500) and that the cost estimate for the Communications with the Community bid be reduced to \$2,500, and for both of these funding amounts to be confirmed at the Strengthening Communities Fund decision meeting on 17 July 2012.
