The Chairperson thanked Mr Findley for his update and for the good work being undertaken by the group.

- (f) Approve a grant of \$1,600 from its 2011/12 Discretionary Response Fund to the North Wai Boardriders Club towards the programmes costs for the January 2012 holiday programme.
