#### 5.2 CASHMERE ROAD SPEED LIMIT REVIEW

Steve Dejong, Traffic Engineer, Transport and Greenspace tabled an information memo regarding the Board's 5 July 2011 request for staff advice on the speed and safety situation on Cashmere Road from Hendersons Road to Hoon Hay Road.

After hearing the staff briefings on the Cashmere Road/Penruddock Rise intersection and Cashmere Road speed limit the Board **agreed** to request a staff report on all possible mitigation measures to reduce speed at the intersection of Penruddock Rise and Cashmere Road, including the reduction in of speed and traffic thresholds, prior to the intersection and other engineering solutions.

### 5.3 WIGRAM ROAD SPEED LIMIT REVIEW

Steve Dejong, Traffic Engineer, Transport and Greenspace tabled an information memo regarding the Board's 5 July 2011 request for staff advice on the speed and safety situation on Wigram Road between Awatea and Haytons Roads in the area of the Broken Run subdivision.

- 6.2 **Traffic and Parking Bylaw Amendment** A memo and attachments was tabled outlining the Traffic and Parking Bylaw Amendment 2012.
- 6.3 **Picton Avenue Reserve Works** The Board were advised that the Earthquake Commission (EQC) are reinstating a spring damaged in the earthquake from private property next door onto Picton Reserve to ensure continuity of water supply to the stream in Picton Reserve.
- 6.4 **Hydraulic Fracturing (Fracking)** Documents regarding hydraulic fracturing were tabled from Environment Canterbury as background information for Board members.

The Board **requested** a seminar on hydraulic facturing be held in early 2012.

6.5 **Quarry Hill Recreation Development** – An information memorandum was tabled regarding a proposed recreational facility on Quarry Hill reserve. There is funding in the capital program this financial year to undertake planning for the reserve. The construction of the play structure will be subject to the Council approving funding in future budgets through the approval of the 2012/13 Annual Plan.
