**Report of an extraordinary meeting of the Hagley/Ferrymead Community Board  
held on Monday 11 June 2012 at 3pm in Committee Room 1,

**1. DEPUTATIONS BY APPOINTMENT**

**1.1 SPORT CANTERBURY AND LINFIELD CULTURAL RECREATIONAL SPORTS CLUB – KIWI SPORT INITIATIVES**

The Board **received** a deputation and supporting information from Rebecca Lambert, Young Persons Adviser at Sport Canterbury, David Sloss, Business Manager of Linfield Cultural Recreational Sports Club and Cathy Baker, Linfield Kiwisport Coordinator, regarding local Kiwisport initiatives.

The deputation thanked the Board for the Strengthening Communities Funding they granted at the inception of the Linfield programme in 2010, and advised that funding has been sourced from the Prime Minister's Christchurch Earthquake Appeal for the remaining two years of the current programme.

- Brenda Lowe-Johnson updated the Board regarding her recent action to highlight housing issues in the City. Board members discussed issues relating to temporary housing, and **requested** the Community Board Adviser contact the Department of Building and Housing to arrange for them to attend a future meeting of the Board.
- The Board discussed the Christchurch Central Development Unit, and some Board members expressed concern at the lack of information the Board has received to date. The Board **decided** to contact the Unit and the Chief Executive of the Canterbury Earthquake Recovery Authority to request weekly updates on the work of the Unit, and to seek clarification on the anchor projects that the Unit is considering.
- The Board Chairperson advised Board members of the presentation by Christchurch Polytechnic Institute of Technology Year 3 Bachelor of Architectural Students on the Linwood Rejuvenation Project that he and staff attended on 22 May 2012. **13. APPLICATION TO THE HAGLEY/FERRYMEAD COMMUNITY BOARD 2011/12 DISCRETIONARY RESPONSE FUND – CANTERBURY PLAYCENTRE ASSOCIATION**

The Board considered a report seeking approval of an application for funding from the Hagley/Ferrymead Community Board 2011/12 Discretionary Response Fund for the Canterbury Playcentre Association. Board members discussed the need for holistic neighbourhood recovery planning.

It was **resolved** on the motion of Tim Carter, seconded by Bob Todd, that the Hagley/Ferrymead Community Board support the application and approve a grant of \$4,830 from its 2011/12 Discretionary Response Fund to the Canterbury Playcentre Association for a Feasibility Study for the Heathcote Valley Playcentre and **requested** the Board be provided with a copy of the Feasibility Study on its completion.

The Board also **decided** to recommend to the Council that it supports the concept of holistic neighbourhood recovery plans, and would welcome the opportunity to discuss this further with the Council. The Board decided to present its recommendation on this matter to a Council Earthquake Meeting.

**14. APPLICATION TO THE HAGLEY FERRYMEAD COMMUNITY BOARD 2011/12 DISCRETIONARY RESPONSE FUND – REDCLIFFS PUBLIC LIBRARY INC**

The Board considered a report seeking approval of an application for funding from the Hagley/Ferrymead Community Board 2011/12 Discretionary Response Fund for the Redcliffs Public Library Inc.

Board members discussed the process for temporary facilities, and were advised that the Board would have an opportunity to provide feedback to the Council on the Transitional Community Facility Project later this month. The Board **decided** to request information from staff on the Council contributions on the transitional community facility being established in St Albans.

**STAFF RECOMMENDATION**

It is recommended that the Hagley Ferrymead Community Board approve a grant of \$3,800 from its 2011/12 Discretionary Response Fund to Redcliffs Public Library Inc for Project Coordinator wages.

**BOARD DECISION**

It was moved by Tim Carter, seconded by Islay McLeod, that the staff recommendation be adopted.

Yani Johanson moved, by way of an amendment, seconded by Bob Todd, that the report lie on the table until the meeting of 20 June 2012.

When put to the meeting the amendment was declared **carried**.

**15. STRENGTHENING COMMUNITIES FUNDING – KEY LOCAL PROJECTS 2012/13 REPORT**

The Board considered a report regarding key local projects in the Hagley/Ferrymead Ward.

It was **resolved** on the motion of Islay McLeod, seconded by Brenda Lowe-Johnson that the Hagley/Ferrymead Community Board recommend:

- a) Te Whare Roimata Trust's Older Persons Project as a Key Local Project and recommend a grant of \$27,000 to be considered by the Metropolitan Funding Committee for the 2012/13 Strengthening Communities Fund.
- b) Te Whare Roimata Trust's Linwood Community Arts Project as a Key Local Project and recommend a grant of \$52,000 to be considered by the Metropolitan Funding Committee for the 2012/13 Strengthening Communities Fund.
- c) Te Whare Roimata Trust's The Bromley Project as a Key Local Project and recommend a grant of \$27,500 to be considered by the Metropolitan Funding Committee for the 2012/13 Strengthening Communities Fund.

- d) The Family and Community Division (Anglican Care) Youth Development Worker Linwood as a Key Local Project and recommend a grant of \$35,000 to be considered by the Metropolitan Funding Committee for the 2012/13 Strengthening Communities Fund.
- e) The Shoreline Youth Trust Fuse Youth Café and in School Project as a Key Local Project and recommend a grant of \$20,000 to be considered by the Metropolitan Funding Committee for the 2012/13 Strengthening Communities Fund.
