#### 2. **DEPUTATIONS BY APPOINTMENT/PUBLIC FORUM**

Mr Bill King from the New Zealand Housing Foundation, Ms Fenn Shaw from Abbeyfield Christchurch Inc. and Ms Margaret Willis from the Housing Plus Charitable Foundation, on behalf of the Hornby Housing Project Partners - New Zealand Housing Foundation, Abbeyfield NZ, Housing Plus and The Salvation Army. The group requested the Council sell the land in question to the Hornby Partners at a rate of \$525,000.

#### **COUNCIL MEETING OF 17 MAY 2012**

#### LAND SALE AND SOCIAL HOUSING DEVELOPMENT, HORNBY 13.

Councillor Keown moved, seconded by Councillor Broughton, that the Council:

- Decline the proposal received from the Consortium to purchase the Council owned block at (a) 2 Goulding Avenue (now known as 36 Shands Road), Hornby; and
- Resolve that the Christchurch City Council proposal to develop social housing units on the (b) Council's owned land at 2 Goulding Avenue (now known as 36 Shands Road), Hornby proceed.
- (c) Note that staff work with Beckenham Housing Trust to find further partnership opportunities in order to grow the Trusts housing numbers.

- (a) The Council agree to the proposal received from the consortium to purchase the Council owned block at 2 Goulding Avenue (now known as 36 Shands Road) Hornby. Subject to the development of and commitment to a legal instrument, which would ensure that the Council would retain the right to repurchase the land at the discounted rate, should it be offered outside the Consortium's social housing portfolio.
- (b) The sale of Goulding Avenue is subject to New Zealand Housing Foundation receiving \$2.5 million from Community Trust and \$2.5 million from Government.
- (c) The site will return to Council ownership if building has not started by June 2013.
- (d) The Council reserves the right to participate in the Consortium should the opportunity arise.

When put to the meeting clauses (a), (b), (c), and (d) were taken separately.

#### 8. EARTHQUAKE RELATED RATES RELIEF

Councillor Keown moved, seconded by Councillor Button, that the Council:

- (a) Note the cost of increasing the current earthquake related rates remissions from 40 to 100 per cent for residential and other properties that are unable to be occupied, and backdating that increase to the date on which the properties became unable to be occupied would be \$7.361 million.
- (b) Note that Work and Income provides the Temporary Accommodation Assistance Allowance to homeowners whose homes are uninhabitable and whose insurance cover for temporary accommodation has, or is about to, run out.
- (c) Note that the Council will consider the 2012/13 remissions policy, including rating residential properties which are currently eligible for 40 per cent rates remission, at bare land value only, when it deliberates on the Annual Plan.

Councillor Johanson moved, by way of an amendment, seconded by Councillor Livingstone, that:

Noting the significant financial hardship being faced by those who have been unable to remain in their own residential properties due to the earthquakes, that the Christchurch City Council resolve to grant for the 2011/12 financial year 100% rates remission for those residential property owners (as of the 1st of July 2011) whose residential properties have been made uninhabitable by the earthquakes (for the period of time in which they have been unable to be inhabited). Rates remissions will only be considered following the receipt of an application by the ratepayer and the application must be received by 30 September 2012.

When put to the meeting the amendment was declared **lost** on division number two by 4 votes to 10, the voting as follows:

For (4): Councillors Carter, Chen, Johanson and Livingstone

Against (10): The Mayor and Councillors Beck, Broughton, Buck, Button, Corbett, Gough,

Keown, Reid and Wells
