#### 9. BOARD MEMBERS' INFORMATION EXCHANGE

Specific mention was made of the following matters:

- The Board **decided** to ask staff to ensure future advertisements regarding fire restrictions be less ambiguous, as recent advertisements had referred to restrictions being lifted in "urban" areas, which had resulted in confusion to some members of the public who took this to mean residential areas.
- The Board decided to ask staff if monitoring of freedom camping had been carried out at Camp Bay, or any other parts of the Lyttelton/Mt.Herbert area, as part of the monitoring carried out by staff to report to the Council on managing freedom camping.
- The Board **decided** to ask staff whether funding for the Lyttelton Museum and other local organisations, such as the Lyttelton Information Centre, was going to continue to be available through the Council's operational budgets, as it had been for the first five years of Banks Peninsula being part of Christchurch City Council.
- The Board decided to convey to staff that community feedback regarding the Facilities Rebuild
  Project had indicated the preferred priority for a community facility for Governors Bay residents
  was the Allandale Hall, rather than the Governors Bay Community Centre, as had previously
  been advised by the Board.
