5. BRIEFINGS

5.1 HOUSING AND COMMUNITY FACILITIES

Sumner Community Centre Site and Sumner War Memorial

The Board **received** a briefing from Kevin Bennett, and a supporting memo, providing advice to the Board regarding its recommendation to the Council seeking approval for the allocation of Discretionary Response Funds for remediation of the site of the former Sumner Community Centre, and the repositioning of the Sumner War Memorial.

Board members were advised that the aggregation of the site will be done by the Council's Community Support Unit as part of maintaining the site to a reasonable standard, and that professional advice has been received recommending that the Sumner War Memorial not be moved temporarily for ANZAC Day to avoid exacerbation of earthquake damage to the memorial.

- The Board discussed the new Christchurch Central Development Unit, established to lead the rebuild of Christchurch central and to deliver the vision in the Central City Plan prepared by the Christchurch City Council. 10. APPLICATION TO THE HAGLEY/FERRYMEAD COMMUNITY BOARD 2011/12 DISCRETIONARY RESPONSE FUND – ANGLICAN PARISH OF ST CHADS LINWOOD

The Board considered a report seeking approval of an application for funding from the Hagley/Ferrymead Community Board 2011/12 Discretionary Response Fund for the Anglican Parish of St Chads Linwood.

STAFF RECOMMENDATION

That the Hagley/Ferrymead Community Board approve a grant of \$10,000 from its 2011/12 Discretionary Response Fund to the Anglican Parish of St Chads Linwood for the salary of the community development worker.

BOARD DECISION

The Board considered a report seeking approval of an application for funding from the Hagley/Ferrymead Community Board 2011/12 Discretionary Response Fund for the Sumner Residents' Association.

It was **resolved** on the motion of Bob Todd, seconded by Islay McLeod, that the Hagley/Ferrymead Community Board support the application and approve a grant of \$2,020 from its 2011/12 Discretionary Response Fund towards the 2012 Sumner Community Street Party for event equipment and promotions.

12. APPLICATION TO THE HAGLEY/FERRYMEAD COMMUNITY BOARD 2011/12 DISCRETIONARY RESPONSE FUND – SUMNER URBAN DESIGN GROUP

The Board considered a report seeking approval of an application for funding from the Sumner Residents' Association from the Hagley/Ferrymead Community Board 2011/12 Discretionary Response Fund for salaries and wages for the Sumner Urban Design Group.

Staff provided additional advice and responded to questions from Board members in support of the staff recommendation to decline the application.
