
## Lei-Anne BASHIR-ELAHI (NEE DOBBS) Independent

Smoke-Free Ecology

Criminalisation is a very poor health service indeed. Prohibition of cannabis in particular fails all ethical and quality standards. Empowering people with informed choice is key to improving, promoting and protecting the public well-being.

The smoke-free environments amendments can treat marijuana like tobacco, with credible health warnings, harm reduction (vaporiser use) and/or replacement therapies.
