Currently Hagley Park is quite well served with both tarmac & shingle walking tracks. These are well used.

As a jogger who uses Hagley Park frequently, a separate running path would both encourage joggers to use the facility and could be an asset to tourists. I often meet tourists jogging who do not know where 'their' path leads - a specific jogging path would make this obvious and could be identified with distance markers and directions.

There are also several areas of Hagley where runners & walkers take 'short cuts' and have created dirt paths - these are both unsightly & dangerous because of ruts. A re-aligned jogging path could eliminate these tracks.

Finally, such a jogging path would be an asset towards the community's health.

I believe the Council should create specific jogging paths in Hagley Park.
