Issue

Right of Way (ROW) on property at 87 Harbour Rd, Brooklands.

This Row is the vehicle entrance to a restaurant car park and then carries on past the private residence. It ends at a 6-foot fence. The ROW does not give walkers a view of the Brooklands Lagoon and stops at the fence so that they have to turn around and go back the way they came anyway. It is dangerous for walkers as cars are constantly going in and out of the car park. Also it gives us no security in our own home with some people even sitting on our doorstep smoking. We have had to contain youths under the influence of alcohol with a metre long crowbar who have gained access to the property by the ROW. Luckily it was only our property damaged and not a person. It is our view that this walkway offers nothing to the public, but causes us a lot of stress. There is a perfectly safe new footpath only 3-4 metres away that allows people to walk safely and leads them to the lagoon foreshore or boat ramp. We have a lot of support for the removal of the ROW from the local people and walking groups. Please note attached petition.

Action

Immediate removal of the ROW on our title.

The building of a boardwalk that goes from the end of Harbour Rd to the reserve in the Blue Lagoon Subdivision. Until such time the boardwalk is built people can use the footpath.

Why

For the safety of walkers and users of the car park.

For our own personal safety.

For the security of our personal property.

The fact that it is common sense that this ROW is not needed.

Also the removal of the ROW is supported by hundreds of people.

The boardwalk will offer a very educational and enjoyable element to the walkway around the Lagoon.

Issue

Town Hall and Convention Centre

Support the maintenance and refurbishment of the Town Hall. However I do

not support the expansion of the convention Centre at a cost to the ratepayer.

Action

Maintain and refurbish Town Hall.

Convention Centre expansion should be funded from profits made by this business. It should not be funded by ratepayers.

Why

If there is a real need to expand the convention centre, then this should be covered by the profits of this business.

Issue

Any further commercial facilities at the Groynes or Spencer Park.

The Groynes and Spencer Park offer a unique place for families to go where they interact together. It is very important that these places are kept free of adult distraction so that it is truly a family experience. If there was a café or bar on these sites then it would encourage parents to send their children off to play while they are in another building drinking coffee or beer. This will put children at risk of predators and destroy the family bonding that these places create at present.

Action

Not to allow any more commercialisation in these 2 parks.

If there is a need for a person to have latte while on a family picnic then this could be made available as a takeaway from the facilities already there, or else a portable caravan could be present in the parks on busy days.

Why

To keep families together and our young people safe.

There would be a further breakdown of families if these areas were to change.

Families go camping or to the park to be together, not so that Dad can sit in some bar and have a drink while the kids entertain themselves.

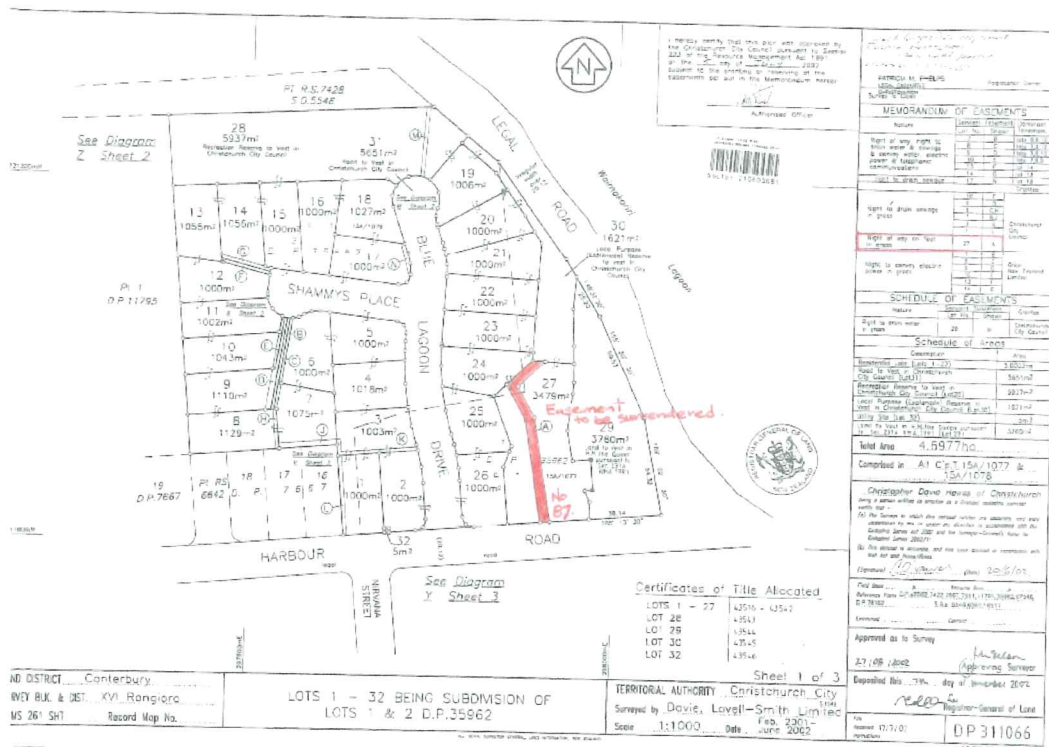
I believe the council have a social obligation to offer places that are family


