An area that is on its way up. I am surrounded by streets that have been very successfully enhanced in the past - Strickland, Baretta & Roker, to name a few. The Council has done well here, & householders have responded for the most part, with tended gardens & well-kept houses. Such things are infectious.

I have done my bit, sorting the garden, planting trees, & having the house painted - all on the slim income of a freelance journalist.
