- I oppose the sale of 43a Edgeware Rd for housing.
- I would like to see it retained for Community recreational use — ie A Pool/green space/Garden
- The Heritage of The 1930's—"building a Community Pool" has been lost — please restore our faith in the - C.C.C. and give the Community what they want.
- If St Albans could raise funds to build a pool in the Depression years of The 1930's — surely we can do the same in future years?
- Infill housing on L3 land is producing a larger population for Recreational needs <sup>in St Albans</sup>
- A large "Baby Boomer" population <sup>in St Albans</sup> and their grandchildren are looking for leisure swimming. Apparently the new Graham Condon Pool will not provide for <sup>Swim clubs or</sup> Leisure swimming — neither does the Centennial. Where can the elderly and youth splash, duck, dive & play in water?
- A needs analysis survey for the Graham Condon Centre ~~will be~~ based on Westin Christchurch. Once again Inner St Albans are not included and yet we are told that is the reason why we can't have a pool in St. Albans. It doesn't seem that the needs of St Albans have been assessed properly.
- The site needs to be cleared and handed to The Community to provide a Recreational Facility & Pool surrounded by a Community garden & native green space to be enjoyed by all for now and future generations in a sustainable community.
