PURPOSE OF REPORT

1. The purpose of this report is to present to the Board two applications for funding assistance from the Spreydon/Heathcote 2012/13 Youth Achievement Scheme fund.

EXECUTIVE SUMMARY

2. Funding is being sought by the following applicants:
 - a) Sheldon Ogilvie, 14 years old from Spreydon, to represent Fencing New Zealand at the Asian Junior and Cadet Fencing championships in Bali from 30 September to 8 October 2012. Sheldon did not receive notification of his selection until 29 August, only four weeks prior to his event.
 - b) Samuel Lees, 14 years old from Huntsbury, to represent Canterbury Under 15 years Basketball at the national tournament in Wellington from 8 to 12 October 2012.

BACKGROUND

Sheldon Ogilvie

14. Sheldon attends Cashmere High School and has been fencing for the last three and a half years. He currently trains six times per week and in recent years he has been involved in two high performance training camps during the summer holidays. In 2012 Sheldon has placed second in Epee at the Christchurch Secondary School Championships; second in Epee at the U15 New Zealand Championships; third in Epee at the U20 New Zealand Championships; and second at the U15 Australian Championships in Sydney.
15. Sheldon will be competing in Epee at the Asian Junior and Cadet Fencing championships in Bali with his coach and two other fencing athletes from Christchurch. Each country can enter four competitors to each individual event and one team of four competitors to each team event, therefore a maximum of 48 competitors. Sheldon's coach believes the Asian championships will be an important event to gain exposure and competition experience that is not available in New Zealand. It will also help him progress towards gaining a world ranking and eventually qualify to go to the Junior Olympics in 2014.
16. Sheldon has not been able to fundraise due to the short time frame he has had since being selected. In the future he plans to gain more experience overseas and get selected for Oceania to go to the 2014 Junior Olympics 2014.

Samuel Lees

17. Samuel attends Middleton Grange School and has been playing basketball for seven years for his school and the Pioneer Basketball Club. He made the Canterbury representative team for the first time when he was ten years old and has made age group representative teams ever since. This year he is in the Canterbury Under 15 team that won the South Island competition in order to qualify for the national tournament in October.
18. Samuel coaches a Year 7 and 8 (10-12 year olds) team at school and also referees for this age group. He enjoys this perspective of the game and seeing the younger players improve. Outside of basketball, Samuel has represented his school in cross country and athletics. He has played football in the past but is now focusing on basketball.
19. Samuel has put money aside from his part-time job and has raised money through selling second hand goods. In the future he hopes to get a scholarship to play college basketball in the United States of America.
